- 2. The functions and powers of the Governing Body are as stated below:
- (i) Consider and decide on the programmes of activities of the Board and to add new schemes to ongoing activities of the Board.
- (ii) Appoint auditors for the Board
- (iii) Consider the Annual Report, Audited accounts and balance sheet of the Board for the outgoing years.
- (iv) Add to and amend, with the prior approval of the Government of India, the rules of the Board.
- (v) Supervise generally the functions of the Executive Committee and to provide guidance thereto.

- (vi) Delegate any of its powers by resolution to the Executive Committee/committees constituted by Chief Executive or any officer of the Board.
- 3. The Governing Body shall meet, at least, once in every year which shall be called the Annual General Meeting (AGM) of the Governing Body. The Chairman of the Governing Body shall preside over at all the meetings of the Governing Body. In the absence of the Chairman at any meeting of the Body, Vice-Chairman shall preside over the meeting. All meetings of the Governing Body shall be held at the time and place to be determined by the Chairman of the Governing Body. The Chairman may also convene special meetings of the Governing Body on the written requisition of not less than one-third of members.
- 4. Unless the membership of a member is otherwise determined, all members shall cease to be members on the expiry of three years from the date on which they become members of the Governing Body.
- 5. Members of the Governing Body shall not be entitled to any remuneration from the Board. However, non-official members of the Governing Body shall be paid by the Board such as travelling and daily allowances as may be provided for in the Rules to be made in this behalf in respect of any journeys undertaken by them for attending the meeting of the Governing Body or in connection with any other business of the Governing Body.
